


To create a FollowMyHealth® Universal Health Record from an Invitation from your provider, please follow the process below:

Once you have clicked the registration link from the email invitation, you will see the following screens with the below mentioned options:



Select the "Sign Up and Connect" option.



Next, is the username and password screen. By default, the email address your invitation was sent to will be in the username field. It is recommended that you use your email address as your username.

However, if you share an email address, or prefer to use a different username, you can remove the email and create a username of your choice.

Once the username has been created, you will then move to the password creation section of the page. Create your password according to the specified list to the right. As they are completed, the list will turn green with check marks next to each item. Any item still in red means the criteria has not yet been met.

Step 3: Enter Invite Code

- This is the invite code entry and its format is designated in the invitation you received from your medical organization

Step 3: Enter Invite Code

The invite code is a secret between the patient and the healthcare provider with whom you are connecting. If you were not given a code directly from your provider, it will most likely be either the last four digits of your social security number or year of birth (yyyy). Remember, if you are setting up a proxy account for a child or dependent adult, the code applies to that patient and will be the last four digits of his/her social security number or year of birth (unless you were given a specific invite code from the provider for that patient).
